

OCCUPATIONAL LICENSE IN WEST FELICIANA PARISH



In accordance with applicable Parish Ordinance and State Law, all businesses having a physical location in West Feliciana Parish are required to obtain an Occupational License in West Feliciana Parish annually. Businesses that have a Municipal Occupational License are exempt from this requirement. Occupational License expire each year on December 31.

APPLICATION:

The following is necessary for you to obtain an Occupational License:

- 1) If applicable, must ensure zoning compliance with the West Feliciana Parish Council, located at 5934 Commerce Street and can be reached at 225-635-3864.
- 2) If applicable, obtain a Sales Tax Collector Number from the West Feliciana Parish School Board. They are located at 4727 Fidelity Street and can be reached at 225-635-3891.
- 3) Complete the Application for an Occupational License.
- 4) SUMBIT the completed Application along with correct amount due to the West Feliciana Sheriff's Office, located at 4785 Prosperity Street and can be reached at 225-784-3101.

The License must be prominently displayed by the licensee in the place of business.

IMPORTANT THINGS TO REMEMBER:

- It is your responsibility to ensure timely and correct submission of the application and payment. The application may be picked up in person or downloaded from www.wfpso.org. Assistance is available for computation of the tax due by downloading the Occupational License Tax Manual at www.wfpso.org.
- All Occupational License expire on December 31 of each year. You are required to obtain a new license by the last day of February of each calendar year. Any business that has not obtained their license by that day, shall be deemed delinquent and are subject to the payment of delinquent interest and penalty. Delinquent interest and penalty may be computed from March 1 of the calendar year for which they are due.
- Upon termination or transfer of the business, the owner shall make a final return and payment within 15 days of the date of selling or quitting the business.
- Failure to follow applicable parish ordinance and state and federal law may ultimately result in assessments and legal action against you.
- Occupational License Applications and payments can be dropped off in person at the West Feliciana Parish Sheriff's Office at 4785 Prosperity Street or mailed to PO Box 1844, St. Francisville, LA 70775 ATTN: Occupational License.
