### PARISH OF WEST FELICIANA

# **ORDINANCE NO. 2023 JUNE 12-01**

AN ORDINANCE TO AMNED ORDINANCE NO. 2020 MARCH 09-02 AND REVISE CHAPTER 34 OF THE WEST FELICIANA PARISH CODE OF ORDINANCES, TO PROVIDE FOR RATES AND FEES TO BE CHARGED BY CONSOLIDATED WATER DISTRICT #13 AND THE TUNICA WATER SYSTEM; AND TO PROVIDE FURTHER WITH RESPECT THERETO.

### THE WEST FELICIANA PARISH COUNCIL HEREBY ORDAINS:

### **SECTION 1**

Sec 34-1. Uniform Rates and Fees is repealed and reenacted to read as follows:

- a. Deposit: New accounts require a deposit of \$50.00, which shall be applied to the customer's final bill if service is terminated.
- b. Meter Installation (payable in advance):
  - i. ¾" \$500.00
  - ii. 1" \$650.00
  - iii. 2" and larger Cost of meter and materials
  - iv. If a customer service line is within 300 feet of the Parish Water main line, the customer is responsible for time and materials to connect.
  - v. The customer service line shall include a shut off valve and valve box with cover, which is to be located no more than 3 feet from the Parish's meter box. Service shall commence on the date set by the Parish and then only after inspection and approval of the customer's service line.

## c. Water Usage:

- i. Residential
  - i. \$22.00 per month minimum for 0-2,000 gallons
  - ii. \$4.50 per 1,000 gallons over the minimum usage
- ii. Commercial
  - i. \$60.00 per month minimum for 0-10,000 gallons
  - ii. \$4.50 per 1,000 gallons over the minimum usage
- iii. Government
  - i. \$56.25 per month minimum for 0-10,000 gallons
  - ii. \$4.50 per 1,000 gallons over the minimum usage

#### d. Other Fees:

i.	Activation Fee for Existing Meter	\$25.00
ii.	Reconnect Fee	\$50.00
iii.	NSF Fee	\$25.00
iv.	Transfer Fee	\$20.00
٧.	Name Change Fee	\$15.00

vi. Late Charge Fees 10% of Water Balance

vii. Re-read Fees (if original was correct) \$25.00

viii. Damaged Meter Replacement Cost of Meter and Materials

ix. Meter Box Replacement Cost of Materials

x. Unauthorized Use Fee \$500.00xi. Calibration Fee (if meter working properly) \$100.00

Sec. 34-2. Disconnect, Reconnection, Meter Removal and Reinstallation Upon Failure to Pay.

- a. Service will be disconnected, and the meter locked if full payment is not received within 30 days of the payment due date.
- b. Reconnection shall require payment of the entire balance due for the address served by the meter, plus a reconnection fee, and a deposit of \$50.00.
- c. Damaging or Tampering with a meter or meter lock shall be cause for removal of the meter.
- d. Reinstallation of the meter shall require payment of the entire balance due for the address served by the meter, a reconnection fee, a meter installation fee, and a deposit of \$50.00.
- e. Damaging or Tampering with a meter or meter lock shall be a misdemeanor punishable by a term of imprisonment of up to 30 days in the parish jail or a fine of up to \$500.00 or both.
- f. Connection to the water system without compliance with the provisions of this ordinance shall be considered theft and shall subject the violator to a charge under Louisiana criminal law.

Sec. 34-3. Disclosure: The Parish shall charge the customer for all associated costs pertaining to damages caused by the customer.

Sec. 34-4. Any user who changes from any other water source to the parish water system shall obtain a permit and engage a licensed plumber to ensure that the customer line is properly flushed. A customer who has exited the parish water system to an alternative water system and

then seeks to reconnect to the parish water system shall obtain a permit, which shall require an inspection to ensure compliance with state and local water system regulations.

## SECTION 2

Prior to collection of the foregoing rates, fees, and deposits is hereby ratified and confirmed.
